## How to make a bequest

Gifts are welcome at any level and can be simply stated in your Will or codicil. We would advise you consult your lawyer in these matters to ensure your Will properly represents your wishes in all respects.

If your assets are held in a Family Trust, you may give your Trustees a simple Memorandum of Wishes stating that on your death you wish the Trustees to make a gift to the NZTrio Foundation. Your Memorandum can describe the gift in a similar way to that set out for a Will.

You may find the following wording helpful:

*I give to the NZTrio Foundation trust board, (% of estate, the residue of my estate, or sum of money, or description of property or assets) for general purposes, for which the receipt of an authorised officer of the Foundation shall be a full and sufficient discharge to my trustees.*

Bequests to the NZTrio Foundation are used to enable NZTrio to continue to inspire and enrich the lives of others through music.
